Welcome/Call to Order

• Chair C. Covert-Bybee called the meeting to order at 2:32p CST.

Roll Call

• A. Perry called the roll; quorum was present; attendance reflected in chart above.

Review and Adoption of the Agenda

- Chair C. Covert-Bybee reviewed and called for a motion to adopt the agenda.
- Motion:
 - o T. Black motioned that the committee adopt the agenda as presented.
 - o V. Beauchamp seconded the motion.
 - All voted in favor; 0 abstained; the motion carried.

Review and Adoption of the Minutes

 Chair Covert-Bybee reviewed the minutes from the previous meeting and called for a motion to adopt them as presented.

Rules Documentation

- A. Perry shared that the promulgation template for rules will be updated to be more consistent across all the existing and future rules. She displayed an example of what she has worked on. No concerns; RC supports the transition to the new template.
- A. Perry requested feedback regarding the RC's preference to have rules posted separately as individual rules (current process) or to switch to having them in one document.
 - RC's preference is to have all of the OTCC rules in one document on the OTCC Governance
 Documents webpage.
 - Final rules will be posted with rule content/language, adopted date, effective date, amended date (if applicable), new effective date (if amended).
 - Other rule history and purpose will be left on the promulgation template for the rule (ex: public comment periods).

Rules Development:

- Drafted amendments to the Rule on FBI Criminal Background Checks (FBI CBCs)
 - Some original language struck to increase clarity and prevent redundancy with added language
 - Added language clarifies the process for states to move forward with issuing OTC privileges to practice even with challenges implementing FBI CBCs.
 - Added language explains states' utilization of "legal impossibility" on a temporary basis.
 - Added language explains practitioners' responsibilities to obtain FBI CBC when possible.
 - o Draft version voted forward to the Executive Committee for their review.

Motion:

- T. Black motioned that the committee adopt the substance of the rule as presented and send it to the Executive Committee for review, with delegated authority to the Rules Chair, Legal Counsel, and Executive Director to add in correct citations/references and correct any grammatical or spelling errors.
- V. Beauchamp seconded the motion.
- All voted in favor; 0 abstained; the motion carried.
